### flock RULES AND REGULATIONS

- 1. All goods offered for sale <u>must</u> be the work of the stall-holder.
- 2. Bought in goods will not be allowed.
- 3. Items which are produced primarily from the assembly of bought parts will not be allowed.
- 4. Each member may only sell the original craft as notified on the booking form. Any change or addition to stock must be notified to the Barn Office and approved in writing before the event.
- 5. Toy makers must ensure that they comply with the EU regulations.
- Bookings will only be confirmed on receipt of the non-refundable administration fee. If successfully selected, full payment should be made by <u>5 October 2020</u>. BACS transfer to: Woodend Arts Ltd, Sort Code: 40-52-40, Acct No. 00020769 Please quote flock ONLINE and your Trading Name.
- 7. If successful a participant will be required to supply the Barn with a record detailing images and descriptions of the unique and exclusive products, they will be offering as part of flock ONLINE 2020 by <u>5 October 2020</u>
- 8. The participant will be liable for the distribution of purchased goods and all delivery charges **must be included** in the stated selling price. Distribution must be done within 5 working days of the end of the event.
- 9. Any payments received for goods bought directly via the flock ONLINE website will sent to the participant within 3 working days of the end of the event. Please note that this will be minus 5% admin costs for card sales.
